Out for multiple plumbing issues. Boiler is not firing due to a low voltage issue. Cannot further diagnose past that point. Found that the incorrect recirculating pump was installed and was backwards causing hot water supply issues. Found that the homeowner was having issues with a few fixtures, display and placement. Found that the toilets have a brown ring around the base that was causing the homeowner some concern. Recommended replacing the indirect water heater with electrolysis and reconfiguring the piping to ensure proper install. Recommended pulling and resetting all commodes as well as running a sewer camera to ensure that they were properly installed and not going to cause issues in the future. Home has a sewage ejector pump outside.
